3. 議決権行使結果の概況 (国内株式)

2019年10-12月期に開催された株主総会では、126社を対象に議決権行使を行いました。行使議案数では会社提案1,098議案、株主提案4議案でした。会社提案に対する反対率は12.9% (前年同期9.4%)、株主提案の反対率は50.0% (同100.0%) でした。

取締役の選解任の議案では、資本コストに照らしてROEが長期にわたり低水準にある、取締役会の独立性が乏しい、取締役会の構成において規模が過大である、社内取締役を増員する理由が明確ではない、保有株式の額が純資産の相当部分を占める、買収防衛策を導入・継続している場合は、原則として代表取締役の選任に反対しました。また、独立性が十分でない場合の社外取締役の選任に反対しました。

監査役を選解任の議案では、独立性が十分でない社外監査役の選任に反対したほか、独立性の十分な監査役が半数に満たない場合、これに加えて社内監査役の選任に反対しました。

役員報酬議案では、増額に関する情報開示が不足しているため、ストックオプション付与に関する議案においては、付与対象者に経営のモニタリングが期待される社外取締役が含まれる場合や大幅な希薄化が生じる場合などに反対しました。

退任役員の退職慰労金の支給では、金額開示が不十分で議案の賛否に関する判断が難しい場合、支給対象者に監査役が含まれている場合に反対したことから反対率が高くなりました。

買収防衛策の導入・更新については、個別に検討しましたが、株主利益に資する十分な理由が認められないため全ての議案に反対しました。当社は対話を通じて、継続的に企業側に必要性の明確ではない買収防衛策の廃止を促しています。

定款に関する議案においては、剰余金の配当等を取締役会の決議により行うことを可能とする議案、授權枠の大幅な拡大となる議案に反対しました。

株主提案は、長期的な株主利益の増大につながるかどうかの観点から精査した上で、議案の妥当性を個別に判断します。当四半期は、乾汽船において、長期的に業績が低迷していることに加え、必要性の明確ではない買収防衛策を導入していることを踏まえ、取締役選任および取締役報酬総額の引下げに関する株主提案に賛成しました。
